

## Step 1: Photo Release

## Step 2: Waiver & Release

### Important Information

Moline Parks Department and Moline High School are committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. Moline Parks Department and Moline High School continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the above listed programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs.

You are solely responsible for determining if you or your child/ward is physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered illness, injury or impairment, to consult a physician before undertaking any physical activity.

### Warning of Risk

Recreational activities/programs are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers and injuries may occur, including without limitation, those due to inclement weather, slipping, falling, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities/programs exist. In this regard, it must be recognized that it is impossible for Moline Parks Department and Moline High School to guarantee safety.

### WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that in signing up and participating in the above identified programs/activities, you will be expressly assuming all risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your child/ward might sustain as a result of participating *in* any and all activities connected with and associated with said programs/activities (including transportation services/vehicle operation, when provided.)

As undersigned, I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, origination or cause, that my child/ward or I may sustain as a result of said participation. I further agree to waive, release, disclaim, relinquish and forever discharge all claims I or my minor child/ward have, may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the City of Moline, Moline Parks Department and Moline High School, including their respective officials, officers, employees, and volunteers of each. I further agree to indemnify and hold harmless the City of Moline, Moline Parks Department and Moline High School, including the respective officials, officers, employees, and volunteers of each for any and all losses, costs, damages, claims, or attorneys' fees adjudged or assessed against any of the aforesaid entities.
